Terms and Conditions

- 1. A 50 USD Credit Bonus will be added to client's trading account on the first one-time deposit after bonus registration.
- 2. The Credit Bonus is applicable for all trading account types except:
 - (i) MAM Account
 - (ii) Contest Account
- 3. Clients are required to input "JUNO50" under the Referral Code section on the Juno Markets Live Account Opening Application Form upon submission in order to claim the Credit Bonus. Clients can also register this program by login the Trader's Room, go to section "JUNO50 Bonus Registration" and submit the application.
- 4. The minimum deposit to apply for the Credit Bonus is USD 25 or currency equivalent.
- 5. The Credit Bonus will be applied to the trading account only after the acceptance of the terms and conditions.
